**MT. BACHELOR LLC ENTRY FORM
RELEASE/ASSUMPTION OF RISKS AGREEMENT**

RELEASE AGREEMENT. In consideration or participation in this event, the participant, or his/her parent or legal guardian if the participant is under age 18, hereby agrees to release Mt. Bachelor LLC its officers and directors, owners, members, agents, landowners, affiliated companies, employees and any volunteers, organizers and/or sponsors of this event, (hereinafter "Mt. Bachelor") from any and all claims for property damage, injury or death which the participant may suffer or for which he or she may be liable to others, in any way connected with his/her preparation, practice, or participation in this event. This release agreement shall apply to any claim for property damage, injury or death, even if caused by the negligence of Mt. Bachelor. The only claims not released are those based upon willful or intentional misconduct.

EXPRESS ASSUMPTION OF RISKS. The participant and his/her parent or legal guardian, if the participant is under age 18, acknowledges that participation in this event and related activities involve inherent risks and dangers that may cause serious injury or even death. If, for any reason, the above Release Agreement provision is not effective, the undersigned agrees, in consideration of participation in this event, that no claim will be brought or maintained by or on behalf of the participant against Mt. Bachelor for any damages, injury or death which the participant may suffer or for which he or she may be liable to others, in any way connected with his/her preparation, practice or participation in this event wherein the inherent risks of this event constitutes a substantial factor in causing the damage or harm.

I also agree that all disputes between the undersigned or minor participant and Mt. Bachelor arising from this event will be governed by the law of the State of Oregon and the exclusive jurisdiction thereof shall be in the state courts of the State of Oregon, and the venue for these disputes shall be in Deschutes County, Oregon.

If any part of this contract is determined to be unenforceable for any reason or in any circumstance, it is intended that all other terms will be enforced in all other circumstances.

THE UNDERSIGNED HAS CAREFULLY READ AND UNDERSTANDS THIS AGREEMENT AND ALL OF ITS TERMS. THE UNDERSIGNED UNDERSTANDS THAT THIS DOCUMENT IS AN AGREEMENT OF RELEASE AND/OR EXPRESS ASSUMPTION OF RISKS THAT WILL PREVENT THE UNDERSIGNED AND/OR THE MINOR PARTICIPANT FROM RECOVERING DAMAGES FROM MT. BACHELOR IN THE EVENT OF PROPERTY DAMAGE, INJURY OR DEATH. THE UNDERSIGNED, NEVERTHELESS, ENTERS INTO THIS AGREEMENT FREELY AND VOLUNTARILY AND AGREES IT IS BINDING ON THE UNDERSIGNED AND PARTICIPANT AND THE HEIRS AND LEGAL REPRESENTATIVES OF THE UNDERSIGNED AND PARTICIPANT.

IF SIGNING FOR A MINOR, I VERIFY THAT I AM THE PARENT/GIARDIAN AND/OR HAVE THE AUTHORITY TO ENTER INTO THIS AGREEMENT ON BEHALF OF THE MINOR PARTICIPANT. I AGREE TO BE BOUND BY ITS TERMS.
